We would need you to be more focussed in your request before we could provide any information. Walsall Hospitals NHS Trust comprises of 4 main divisions and numerous departments, all of which will process personal information to a greater or lesser extent.

We could hold patient information in paper/electronic format and depending on the system that would be from a database to a simple word document.

This part of the request is therefore refused, but if you are able to limit the scope and define a more specific area of enquiry we will of course do our best to assist you.

The Trust only uses agencies to assist recruitment in exceptional circumstances. Managers have to demonstrate that the post is hard to recruit to and has been unsuccessful through the normal process 3 times before being allowed to approach an agency. Agencies must be OCG registered (which is confirmed with the Head of Procurement). Whilst there is not currently a written protocol our new appointments policy will reflect this best practice approach.
